



## Rule the Road Teen Driving Event

Parental Consent, Photography Release, Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement

I am the parent or legal guardian of the Participant. I permit my minor child or ward (the Minor), \_\_\_\_\_, to participate in any and all aspects of the RULE THE ROAD TEEN DRIVING EVENT (the “Event”). I agree and attest that:

1. I understand the nature of the Event and the risks involved. I deem the Minor to be qualified to participate in the Event. I know the Minor’s experiences and capacities related to the Event’s activities and risks. I expressly assume any and all risks associated with participation in the Event. I voluntarily accept those risks on behalf of the Minor and myself.
2. I consent to the Minor’s participation in the Event and hereby agree to pay the State of Indiana, the Indiana Criminal Justice Institute, Alliance Integrated Marketing Services, LLC, Alliance Sport Marketing, LLC, Lakeland Jr/Sr High School, sponsors, driving instructors and other persons or entities who give direction, or instruction, and their directors, officers, agents, and employees (the “Releasees”) for any losses it may suffer as a results of the Minor’s negligent or intentional damage/harm to any equipment or persons facilitating the Minor’s participation in the Event.
3. I agree to not hold any of the Releasees responsible for any loss that may result from participation in the activity on behalf of the Minor or myself.
4. I hereby release, discard, and waive the right to sue any of the Releasees if any loss results from participation or observance of the Event. I waive this right on behalf of the Minor, myself, and my and the minor’s personal representative, assigns, heirs, and next of kin.
5. I agree to assume responsibility and costs for any medical expenses that may result from participation in the Event on behalf of the Minor and myself.
6. The Event may include activities such as a Rollover Crash Demonstration Simulator, a tire change challenge, mounting/dismounting in the cab of a large semi-truck or trailer, driving simulators, and short driving courses in a motor vehicle or golf or go-kart vehicle. The Event may also include an activity known as the Seatbelt Convincer Demonstration Device. The Indiana Criminal Justice Institute, Alliance Integrated Marketing Services, LLC, Alliance Sport Marketing, LLC, its officers and employees, Lakeland Jr/Sr High School, and any other sponsor are released from any and all manner of liability claim, demand, right and cause of action, or suits at law or in equity, for any and all damages, injuries, and losses to me, the Minor and my property, both known and unknown and foreseen and unforeseen, and all consequences thereof incurred or suffered by us or resulting to me or the Minor from or in any way arising out of or connected

with (directly or indirectly) the Minor's participation, including his or her climbing on, seating in, riding on, or dismounting from the seat skid and any other equipment utilized as part of or in connection with the Seat Belt Convincer Demonstration or any other simulators, vehicles or activities involved in the Rule the Road event. I know of no condition, injury or infirmity of the Minor, which could be aggravated by the forces associated with a 7-mph automobile collision.

7. I agree to indemnify and hold harmless the Released Parties, enumerated in Paragraph 2, against any and all claims arising from or related to participant's entry and participation in the activities of the event.
8. I agree, consent, and authorize the Lakeland Jr/Sr High School, Alliance Sport Marketing LLC, Alliance Integrated Marketing Services, LLC and the Indiana Criminal Justice Institute, and any of its media partners covering the event, collectively "Releasees", to use my likeness in any photograph, video or other digital media ("Photos") taken or to be taken in connection with the Rule the Road Event, in any and all of its publications and promotional materials, including print, social media, television, or web content.
9. I irrevocably authorize Releasees to copy, edit, enhance, crop or otherwise alter any Photo for use in their publications and promotional materials. I also waive any rights for approval or inspection of any Photos.
10. I understand and agree that all Photos are the property of Releasees and will not be returned to me.
11. I acknowledge that I am not entitled to any compensation or royalties with respect to the use of the Photos.
12. I agree to release and forever discharge Releasees and its affiliates, successors and assigns, officers, employees, representatives, partners, agents and anyone claiming through them, in their individual and/or corporate capacities from any and all claims, liabilities, obligations, promises, agreements, disputes, demands, damages, causes of action of any nature or kind, known or unknown, which I, and anyone claiming on behalf of me, may have or claim to have against Releasees in connection with this release.
13. I sign this agreement on my own behalf and on behalf of the Minor.

I am the parent or legal guardian of the Minor. I have read this document and I am signing it freely. I understand the legal consequences of signing this document, including (a) releasing the Releasees from all liability on my and the Minor's behalf, (b) waiving my and the Minor's' right to sue the Releasees, and (c) assuming all risks of the Minor's participation in this Event, including travel to and from the Event or any events incidental to this Event. I allow the Minor to participate in this Event. I understand that I am responsible for the obligations and acts of the Minor as described in this document. I agree to be bound by the terms of this document.
